In the recent past few years, two very important member of my family were diagnosed with malignant cancer cells that would certainly have drastically decreased their lives' longevity, and cause irrecoverable financial depletion to me due to the cumulative excessive medical bills associated with cancer treatments.

We received the news with a mixture of sadness and joy: sadness because of the possibility of losing these loved ones to these extremely potent diseases, and the cost of the medical for trying to save them; and joy because the medical diagnosis show that the diseases were in their early stages. A few months into the treatment, we found a locally based philanthropic medical institution that supported us with payment of the medical bills which ran into hundreds of thousand dollars.

We are thankful to God that with the institution's help and God's grace, I did not go bankrupt due to medical bills to save my family members, and these family members have recovered tremendously from the disease via early medical intervention. My family is very grateful to this people for their timely support.

As a result, I was moved by a sense of gratitude and compassion to start affecting other less privileged people in my country of birth, Nigeria and consequently the rest of Africa. This is because despite the abundance of natural resources available in the African continent, it still accounts for one of the largest numbers of extremely poor people in the world. The socioeconomic issues that plague the people is beyond leaving it to governments alone to solve; private philanthropists must also engage in a capacity that show love, caring, and understanding of these people's situation on a multi-level of social problems. They need some sort of social supports that create and allow them equip themselves to actively participate in self-sustaining economic activities that will liberate them financially and by extension, benefit the country and the continent of Africa.

The \*OBF\* foundation is focused on a robust set of programs that will always keep us engaged to solve many social problems that are affecting the daily lives of many Nigerians. We have chosen not to limit our reach to just one cause because the social problems are too numerous and interconnected to really make an impact by focusing only on one program.



#### **INTRODUCTION**

These young school leavers of the post-colonial era, on graduation gained employment into the civil service and they rose through the ranks to the top level of their careers. Some of them held leadership positions in the government and in their communities. They spent their most active years serving the nation , they had the best moments having been sponsored through government scholarships in the best Universities in the world and were gainfully employed while many of them retired to join politics and started another work experience .

#### THE LEADERS OF TODAY

The leaders of yesterday have transformed themselves into the leaders of today. #### **CONSTRUCTING THE BARRIERS**

Thus some youth who managed to rise steadily through ranks and

dint of hard work eventually crashed into an impenetrable barriers thereafter

#### **THE BARRIERS**

#### I. The Socio-economic barrier

People born into economic lower class are being prevented from moving to the upper and more affluent class. This group of elites lack resources and economic power influence to create equilibrium in the quest for political power. Invariably, corruption is a major threat to political economic transformation of common man to move up the ladder of political leadership. It is a serious blockage to economic development.

#### 2. Political and Administrative control factors

Our political and Administrative system creates opportunities for few people at the expense of the majority. Political empowerments that create economic power for upward mobility are in the hands of some powerful Oligarchies who had failed to put in place necessary structure that will prepare and equip the youth for leadership roles. A higher percentage above 70 percent youth are dependent thus making independent decision largely dependent hence the advent of godfatherism in our nation politics and public service

#### 3. Gender issues and ethnicity

There are also some invisible barriers women faces in some aspect of leadership. Only few women are able to move up to the organizational hierarchy. This invariably holds women from top —level jobs just because they are women and not because they lack capacity to hold such positions. Men and women also do not generally support women leadership hence opportunities are lost not because of in capabilities but just because of gender issues. What we have therefore is a society where the underprivileged are perpetually kept at the mercies of the privileged few just "because they have and we have not"

We are equally faced with the problem of ethnicity and the resultant rising levels of ethnic tension which limit opportunities to effective networking and idea sharing among the youth for nation building

#### Corruption

Corruption is a global threat to leadership positions. It is a serious blockage to economic development and a limiting factor to human resources empowerment and development. The same leaders who had acquired illgotten wealth often used that affluence to retain themselves in the corridor of power to the exclusion of ordinary man in the society. It is therefore a wewe affairs and situation. Democratic change in this situation became very difficult as the wealthy individuals use their economic powers to remain in power perpetually

#### Resultant effects of the Barriers

Youth leadership opportunities are knowingly and unknowingly overlooked by the adults who had held on to leadership positions perpetually. Most adults in most cases consider themselves as the champions for youth leadership. That's why they determine who are suitable among the youth for leadership position, youth who must be on oath to remain tied to their apron of oligarchy leadership and when such youth can be put forward for leadership positions. Many adults who are supposed to be advisors recommend themselves for leadership position rather than allow the youth take up such positions

The youth are therefore kept out of power and without means of livelihood to propel their growth for upward mobility.

#### **OLUSEYI BISIRIYU FUNDATION OFFERS MEDICAL SUPPORT FOR STRANDED PATIENTS, PAYS DISCHARGED BILL**

In its mission to continuously assist the poor and vulnerables thay could not afford the payment of their hospital bills; a charity organization known as Oluseyi Bisiriyu Foundation recently visited the State General Hospital at Ijaye, Abeokuta, the Capital City of Ogun State.

The Foundation team on their arrival to the Hospital were warmly welcomed by the Head of Department, Nursing Unit. Mrs. Oluremi Monsuro, alongside other staff of the hospital.

The hospital team thanked the Foundation for its humanitarian intervention and assistance to patients who were in serious urgent needs to pay for their drugs and hospital bills.

The Foundation led by the Programme Officer, Engr. Emmanuel Ojo Enitan were later conducted round the wards to see the patients.

Among those who benefited from the financial medical assistance were those who are still receiving treatment at the ward and those who are supposed to have been discharged but could not afford the payment of the Hospital bill.

While Blessing Godstime received immediate discharge after the Foundation magnanimously cleared off her payment, it was a different case for Tobiloba Akinbode who surfers from Birth Asphyxia, a medical condition resulting from deprivation of oxygen to new born infant that last long enough through the birth process to cause physical harm.

Tobiloba was in a critical condition that the Foundation had to pay all expenses till the last day of her discharged.

Mr. Kehinde Ademuyiwa the Public Relations Officer of the Foundation however assured the management of the Hospital that the Foundation shall continue to give necessary assistance to the hospital in carrying out health service delivery to indigents and vulnerable patients who could not afford the cost of their treatments. He thanked the Hospital management for their cooperation while appreciating the state government for its roles in management and control of Covid 19 in the state.

It will be recalled that the Foundation had also offered financial and medical support to some Ogun state dwellers who suffered from breast cancer and other sicknesses.

Prior to the commencement of this medical assistant program by the Foundation, the Foundation team visited the Medical Director of the Ogun State hospital Dr. Oladeinde to find out the needs of the Hospital and some of the patients who are in critical situation and in need of urgent intervention and assistance.

The medical director lauds the Foundation for such interest in helping the poor, giving life to many and raising their hope, while elucidating on the areas where the foundation could be of assistance to the hospital.
